- All directors, officers and employees of the insured entity and subsidiaries and any person residing in or visiting their home. Also the family of the insured, any guest or customer travelling or visiting them and their consultants
- Mitigation of any financial impact to your company due to ransom payments or related expenses
- Immediate access to expert security consultants to assist in the recovery
- Reimbursement of ransom monies, loss in transit of ransom monies, fees for professional negotiators, legal advice and liability, death or dismemberment, recall expenses, repatriation expenses and additional expenses

- Electronic monthly bulletin on the changing security environment (depending on the insurance company chosen)
- Full, worldwide coverage – even if it is away from your normal operating areas. Your company might be based in the US or Canada, but your staff might need to visit Mexico or Africa etc at very short notice
